In accordance to the instruction received, we attended receiver's stockyard at Gujranwala on 12 and 13 February, 2011 to witness the de-stuffing operation of cargo from 02x20ft containers, the dismantling process of the discharged material, and conduct photography as per the advised protocol. On which we report our findings as follows:

**WITNESSING OF CONTAINERS DE-STUFFING** : De-stuffing of 02x20ft containers carried out in the presence of our representative at receiver's stockyard in Gujranwala.

Prior to the unloading of cargo, both containers seals were checked and found intact. Details are given as under,

**WITNESSING OF DISMANTLED PROCESS** : All the cargo was unloaded manually on ground, the receiver's labour was duly covered with the appropriate PPEs.

Due to the time constraints, dismantling process of only about 300 pieces were witnessed by our representative out of the total quantity. The process of dismantling operation is also shown in the appended photographs.

**PHOTOGRAPHY** : Photographs taken during our intervention are attached as ANNEXURE – A, that forms an integral part in this report.

Although the inspection was carried out thoroughly and with due diligence, the reported findings are limited to the visual examination of the safely and readily accessible portions of the goods only and, therefore, does not serve as evidence that the goods are free from explosive or flammable material of any type. In addition, and due to the nature of the goods and limited access during inspection, items not recorded in the above description may be present.

The responsibility for the above findings are limited to time and place of intervention only.
